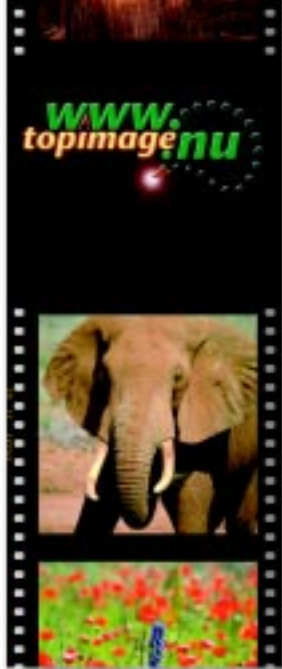
E-mail

Publishing cost

The images at topimage.nu may not be used without payment. When using an image you pay a fee, a publishing cost, for the right to use it for one purpose, and one purpose only! The publishing cost depends on the “purpose of use”.

Registration

Your user-ID and password are strictly personal and should be treated accordingly. Topimage.nu does not take responsibility for the abuse of codes. The publishing cost for high resolution images will be charged to the person/company registered. All downloads are recorded.

Remember that you do not buy the image, you buy the right to use it in a particular project in a specified circulation. If you find the image useful for other projects, you will have to send us a new inquiry.

Records of downloaded high resolution images

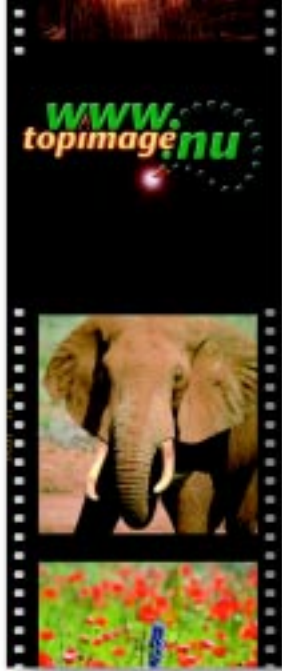
When downloading high resolution images indicate the purpose of use, size and circulation. All downloadings are recorded! If you do not let us know how you plan to use the image, we will send an inquiry to the e-mail address registered. If we have not received an answer within 72 hours, you will automatically be charged the highest possible fee, which is SEK 19.000:-.

A copy of the image as published should to be sent to topimage.nu. If the image is published on the Internet, please send us the website address. An images published on an Intranet should be sent as a screen dump to user@topimage.nu.

Copyright

The law of copyright is simple: Ask first!

The law of copyright gives topimage.nu legal protection of the work. Showing respect for the work of topimage.nu is a routine matter for professionals. The rule of thumb is – ask first.



Important facts for a buyer.

- The copyright of an image belongs to topimage.nu. Keeping the image requires a special agreement with topimage.nu.
- The image may be used according to the agreement with topimage.nu. It can be a specified printed matter, number of edition and circulation. Topimage.nu should always be notified first in case of changes.
- As soon as an image is to be reused, topimage.nu has to give its approval. Reusing an image means a new publishing cost.
- No changes to the image are allowed without permission from topimage.nu.
- New copies of the image cannot be made without permission from topimage.nu, as regards newspapers, magazines, brochures, copies, posters, digital duplicates, etc.
- Digitilizing an image counts as making a new copy. Transferring a digitalized image from one system to another, as well as making a printed copy, is also equivalent to making a new copy. That is why topimage.nu always has to give its permission (first). Topimage.nu's permission for an image to be printed includes the storage of the printed material. The image filed is not to be used for other (printing) matters without permission from topimage.nu.
